POLICY ENGAGEMENT & IMPACT:***Summary of Policy Evaluation Research:***

Over the last 10+ years, my research program has sought to understand and evaluate the role of health and social policies in shaping health care service delivery, health care access, health outcomes and outcome disparities among women across the reproductive life course. My studies have examined a host of federal, state, and local/institutional policies as they impact the reproductive, mental, physical, and maternal health outcomes of women and girls in the United States. Specific policies of focus have included the Affordable Care Act, reproductive health education, national organization recommendations for breast and cervical cancer screenings, federal and state contraceptive provision and access policies, policies affecting minors access to health care services, and reproductive health related laws, among others. I have published and presented my scholarship widely in this area, as described in detail in Section C (RESEARCH) of this CV. My active NIH grants extend this work to address: 1) economic security laws and maternal mental health; 2) state, local and hospital level policies supporting integrated supportive care models for care during the pregnancy and postpartum periods; 3) Medicaid policies for doula reimbursement and care delivery; 4) policy interventions for structural racism and maternal morbidity and mortality, 5) hospital policies to implement maternal safety bundles, SDOH screening, implicit bias interventions, and hospital-community care linkage programs; and 6) academic-hospital-governmental-community partnerships and engagement for policy action in maternal health equity.
